This Privacy Policy explains how we, lifeStylistic ("Company", "we", "us", or "our"), collect, use, disclose, and safeguard your information when you visit our Site, which supports the use and distribution of our cryptocurrency token, STYL, built on the Polygon Mainnet.

By accessing or using the Site, you agree to this Privacy Policy. If you do not agree, please do not use the Site.

### **1. Information We Collect**

We may collect information directly from you, automatically through your use of the Site, and from third-party sources as outlined below.

- **Personal Information**: When you interact with our Site, we may collect information that identifies you as an individual, such as your name, email address, contact information, and any other details you voluntarily provide when subscribing to our mailing lists or completing forms.
- **Blockchain Data**: Transactions on the Polygon blockchain are public. By using the Site, you acknowledge that your wallet address and transaction information may be publicly accessible through the blockchain. We do not control the blockchain or your wallet provider and encourage you to review their privacy policies.
- Automated Information: When you visit our Site, we may collect certain information automatically, including IP addresses, device information, browser type, operating system, and activity data related to your use of the Site.

### 2. How We Use Your Information

We use the information we collect for the following purposes:

- To provide and improve the Site's functionality, features, and user experience.
- To communicate with you about updates, news, and announcements related to the STYL token and lifeStylistic.
- To analyze usage patterns and improve the Site and our services.
